

Fee can be made by eligible bidder/contractor online directly through Debit Cards & Internet Banking Accounts. The payment of EMD can be made online directly through RTGS/NEFT and the bidder would remit the funds at least T+ One working day (Transaction + One working day) in advance to the last day i.e. on or before 05-11-2015 and make the payment via RTGS/NEFT to the beneficiary account number as mentioned in the challan.

**Term and Conditions:-**

1. The bidder has to complete "Bid Preparation & Submission" stage on scheduled time as mentioned above. If any bidder failed to complete his/her aforesaid stage in the stipulated online time schedule for this stage, his/her bid status will be considered as "Bids not submitted".
2. Bidder must confirm & check his/her bid status after completion of his/her all activities for e-bidding.
3. Bidder can rework on his/her bids even after completion of "Bid Preparation & Submission Stage"(Bidder Stage), Subject to the condition that the rework must take place during the stipulated time frame of the Bidder Stage.
4. The Society / tenderer should have work experience of same nature of works at least 50 lacs for last 3 consequential years.
5. The bid will be accepted after the verification of Technical and Financial competency including PAN CARD AND I.T. Return.
6. Other terms and conditions can be seen in the Tender Document available on online as well as in the office of Director Fisheries Haryana, Panchkula.

- 11 The undersigned reserve the right to reject any tender or all the tenders without assigning any reason.
- 12 The societies shall produce an attested copy of the resolution of the Co-Operative department.
- 13 The tender without earnest money bid security will not be opened.
- 14 The jurisdiction of court will be at Panchkula.
- 15 The tender of the bidder who does not satisfy the qualification criteria in the bid documents are liable to be rejected. Summarily without assigning any reason and no claim whatsoever on this account will be considered.
- 16 The Societies/ Contractors should have registered Enlistment certificate from the Haryana Govt. Department as per PWD (B&R) Haryana Specification.
- 17 For the works below 30 Lakh the only co-op. L&C Societies can participate. But if the society fails to tender rates with in ceiling limit then the contractors will be called.
