2. Tender forms are available from the office of DFO-cum-CEO, FFDA, Ambala on cash payment of Rs. 500/- (Non-refundable) accompanied with earnest money in the shape of Bank Draft/ Deposit at call pledged in the name of the officer as mentioned in the table of tender notice against each work.
