The bidder shall be pay for the Tender document, EMD Fees & e-Service fee of Rs. 1000/- online by using the service of secure electronic payment gateway. The secure electronic payment gateway is an online interface between contractors and online payment authorization networks. The payment for Tender Document Fee and eService Fee can be made by eligible bidder/contractor online directly through Debit Cards & Internet Banking Accounts. The payment of EMD can be made online directly through RTGS/NEFT and the bidder would remit the funds at least T + One working day (Transaction + One working day) in advance to the last day and make the payment via RTGS/NEFT to the beneficiary account number as mentioned in the challan.

Term and Conditions:-

- The bidder has to complete "Bid Preparation & Submission" stage on scheduled time as mentioned above. If any bidder failed to complete his/her aforesaid stage in the stipulated online time schedule for this stage, his/her bid status will be considered as "Bids not submitted".

- 2 Bidder must confirm & check his/her bid status after completion of his/her all activities for e-bidding.
- 3 Bidder can rework on his/her bids even after completion of "Bid Preparation & Submission Stage"(Bidder Stage), Subject to the condition that the rework must take place during the stipulated time frame of the Bidder Stage.
- 4 The Society / tenderer should have work experience for skilled / unskilled works at least same amount of work of same nature in One Financial year.
- 5 The bid will be accepted after the verification of Technical and Financial competency including PAN CARD AND I.T. Return.
- 6 Other terms and conditions can be seen in the Tender Document available on online as well as in the office of Director Fisheries Haryana, Panchkula.
- 7 The tender notice may be downloaded from the website of the department <http://haryanaeprocurement.gov.in> & www.harfish.gov.in.
- 8 DNIT & Prequalification criteria can be seen on any working day during office hours in office of the undersigned.
- 9 Conditional tenders will not be entertained & are liable to be rejected.
- 10 In case the day of opening of tenders happens to be holiday, the tenders will be opened on the next working day. The time and place of receipt of tenders and other conditions will remain unchanged.
- 11 The undersigned reserve the right to reject any tender or all the tenders without assigning any reason.
- 12 The societies shall produce an attested copy of the resolution of the Co-Operative department.
- 13 For the works below Rs. 50 Lakhs, the works will be reserved for co-op. L&C Societies only. But if the society fails to tender rates within ceiling limit then the contractor's tender will be considered.
- 14 The tender without earnest money bid security will not be opened.
- 15 The jurisdiction of court will be at Panchkula.
- 16 The tender of the bidder who does not satisfy the qualification criteria in the bid documents are liable to be rejected. Summarily without assigning any reason and no claim whatsoever on this account will be considered.
- 17 The Societies/ Contractors should have registered Enlistment certificate from the Haryana Govt. Department as per PWD (B&R) Haryana Specification.
- 18 All taxes will be deducted as per Govt. instructions.
