



**Term and Conditions:-**

1. The bidder has to complete "Bid Preparation & Submission" stage on scheduled time as mentioned above. If any bidder failed to complete his/her aforesaid stage in the stipulated online time schedule for this stage, his/her bid status will be considered as "Bids not submitted".
2. Bidder must confirm & check his/her bid status after completion of his/her all activities for e-bidding.
3. Bidder can rework on his/her bids even after completion of "Bid Preparation & Submission Stage"(Bidder Stage), Subject to the condition that the rework must take place during the stipulated time frame of the Bidder Stage.
4. The Society / tenderer should have work experience of same nature of works at least 50 lacs for last 3 consequential years.
