Tender forms are available from the office of Director Fisheries, Haryana, Panchkula on cash payment of Rs.500/- (Non-refundable) accompanied with earnest money in the shape of Bank Draft/Deposit at call pledged in the name of the officer as mentioned in the above table against each work. In the case of Cooperative L/C Society the amount of earnest money will be Rs.2000/- or 1% of estimated amount of each work which ever is less.
