Tender forms are available from the office of Director Fisheries, Haryana, Panchkula on cash payment of Rs. 500/- (Non-refundable) accompanied with earnest money in the shape of Bank Draft/Deposit at call pledged in the name of the officer as mentioned in the above table against each work.
