Tender forms are available from the office of DFO Panchkula on cash payment of Rs. 500/- (Non-refundable) accompanied with earnest money in the shape of Bank Draft/ Deposit at call pledged in the name of the officer as mentioned in the above table against each work. In the case of cooperative L/C Society the amount of earnest money will be 1% or Rs. 2,000/- which ever is less as per society rules.
3. The Society / tenderer should have work experience of atleast 25 lacs.
